The candidate for this position must have the managerial and project management experience within these types of construction operations and must comply and ensure their team's compliance with all local, state, and federal, including Federal Railroad Association (FRA) rules and regulations.

- In depth understanding of all company, state, and federal rules and procedures
- Manage job costings
- Forecast and handle the hiring for work staff as needed for projects or future projects

- Managing the inventory and equipment in the division
- Meet with existing clients to ensure customer satisfaction and to listen to customer feedback and develop relationships with new clients
- Work directly with estimators to bid work
- Identify opportunities to bid for work in your region or others
- Schedule work with crews and clients
- Adhere to and promote safe work practices as determined by the company and railroad Able to demonstrate proficiency in all aspects of maintenance of way and track construction
- Communicate progress or any issues of a project with management as well as customers to ensure their feedback and satisfaction is attained
- Review contracts as well as specific project plans to ensure that the work in the field is built to the current specifications

- Possess knowledge of FRA Track Inspection Guidelines is a plus

- Knowledge of all occupational hazards, railway engineering safety regulations and best safety practices for the work being performed

- Ability to supervise the work of others and clearly communicate instructions to crew

Required Credentials:

- Minimum of 8 years related experience in track
- Valid driver's license required
- Bachelors Degree in Engineering / Project Management or related field or otherwise years within related experience
- Previous track and managerial experience

Preferred Credentials:

- 10+ years related experience in track
- Previous track or project management experience in a leadership role
